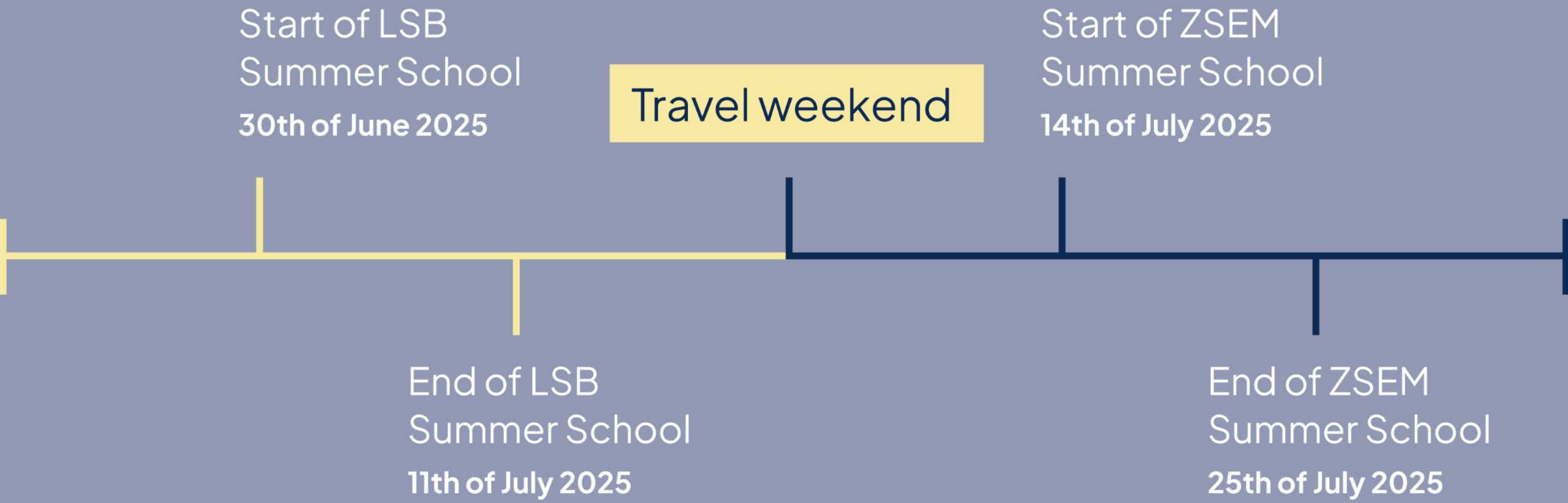

The LSB Summer School is open to high school, bachelor's and master's degree students, as well as working professionals.

## ✓ How to apply?

Visit our website [luxsb.lu](https://luxsb.lu), where you can apply to our Summer School program. Upload all the documentation and personal information. This will be followed by a short interview from our team.

## ✓ Which documentation should I deliver during the enrolment process?

- Your certificate of enrolment into the academic institution
- CV
- Copy of ID or passport
- English proficiency proof

## ✓ What should I expect from the program?

Over the course of two weeks, you can expect an intensive and focused learning experience — an opportunity to explore specific subjects, acquire new skills, engage with experienced professors, and build valuable connections.

## ✓ What will I gain after attending LSB Summer School Program?

By the end of the modules, you will be able to demonstrate intellectual, transferable, and practical skills. Upon completion of the courses, you will receive a certificate.

## ✓ How many courses can I choose?

Students choose two out of three courses to participate in.
